High Hopes offers workshop/certifications for the **Registered** Level twice a year. For 2012 the dates are July 5-8 and December 8-11. In addition, High Hopes offers "Certification on Demand" for "first time" participants who are unable to attend on either of those dates, and for those who need to take the certification a second time ("recertification").

In order to become a PATH Intl. Registered Instructor, you must successfully complete two phases of the certification process.

Phase One (PATH Intl.)

A complete description and application form are contained in the Registered Certification Application Booklet available through PATH Intl. at www.pathintl.org or (800) 369-7433. Any questions that you have regarding Phase One should be directed to the PATH Intl. office.

Phase Two (Host Site—High Hopes Therapeutic Riding, Inc.) "Certification on Demand"

Phase Two "first time" participant requirements:

Upon successful completion of Phase One, you will receive a confirmation letter from the PATH Intl. office. At this point you are considered an Instructor-In-Training (IT). You may retain this designation for twelve months from the date of your confirmation letter. At the end of the twelve months, you must have completed all the components of Phase Two.

- Complete 25 hours of teaching mounted therapeutic riding lessons under the supervision/mentorship of a PATH Intl. Certified Instructor
- Attend a Registered Instructor On-Site Workshop. You must attend a workshop PRIOR to the certification component. Please note that the workshops are valid for 2 years
- Successfully complete a Registered Instructor On-Site Certification

Phase Two "recertification" participant requirements:

- Attend a workshop within two years of the certification and provide proof to the host site
- Complete teaching hours within two years of the certification
- Submit an extra 10 hours of mentored teaching for those who failed both components
- Fill out a new phase two packet (this can include the same references). Must include CPR, First Aid, etc.
- Submit the "failed letter" which has the resubmission deadline on it. It is one year from the date the letter was sent. This letter replaces the IT letter
